**Regarding Open Records Request Dated August 14, 2020**

Dear Mr. Kobliska:

Attached are messages that were received on the Clay County Sheriffs Office Page messenger account, and text relevant to your open records request.

Clay County Sheriffs Office Facebook Page is available online, certain links were removed. We are in the process of trying to contact Facebook about retrieval of removed links.

*15-ORD-226 Cell phone communications, including calls or text messages, made using a private cell phone that is paid for with private funds, are not prepared by or in the possession of a public agency.*

*Communications between the County Attorney and Assistant County Attorneys are protected by attorney/client privileges. Section KRE503 and KRS69.210*

An open case that is under investigation cannot be released at this time; the premature release of the case could affect the outcome. *KRS 61.878 (1)(h) Records of law enforcement agencies or agencies involved in administrative adjudication that were compiled in the process of detecting and investigating statutory or regulatory violations if the disclosure of the information would harm the agency by revealing the identity of informants not otherwise known or by premature release of information to be used in a prospective law enforcement action or administrative adjudication. Unless exempted by other provisions of KRS 61.870 to 61.884, public records exempted under this provision shall be open after enforcement action is completed or a decision is made to take no action; however, records or information compiled and maintained by county attorneys or Commonwealth's attorneys pertaining to criminal investigations or criminal litigation shall be exempted from the provisions of KRS 61.870 to 61.884 and shall remain exempted after enforcement action, including litigation, is completed or a decision is made to take no action. The exemptions provided by this subsection shall not be used by the custodian of the records to delay or impede the exercise of rights granted by KRS 61.870 to 61.884;*

To the best of my knowledge these are all the records pertaining to your open records request.
